ALL other students who have been away from Queen's University for the preceding one or more Fall and/or Winter Terms must complete and sign this form, with the following *exceptions*:

- Students in good academic standing who transferred to a degree program at another post-secondary institution (other than a graduate program) and wish to return to Queen's University;
- Students who graduated from a three-year diploma program at a post-secondary institution;
- Students in good academic standing who have completed more than 3.0 university-level credits (including failures) at another post-secondary institution but did not have a Letter of Permission.
