Canadian Federalism : Research in Progress

I - INTRODUCTION

The central purposes of this inventory are to acquaint those presently engaged in research into Canadian federalism and intergovernmental relations with similar or related work being undertaken elsewhere; and to inform those in government, the media, and the private sector about the kinds of research activity now underway. The Institute hopes that this study will form the basis of a continuing inventory of research in progress on Canadian federalism. It is one element in a broader attempt to help encourage a network of intellectual exchange among both practitioners and scholars interested in the Canadian federal system.

The aim is to identify who is doing research on federalism and intergovernmental relations and where it is being done. As well, we provide a brief survey of the general themes or directions in research activity which emerged from our enquiry.

The study was designed in the following manner:
First, a list of possible researchers was derived from a variety of sources which included published bibliographies and university calendars.
Emphasis was placed on six fields: political science, economics, public administration, law, history and sociology.

In May, 1979, 323 questionnaires were mailed, with a covering letter explaining the project and requesting that the questionnaire be brought to the attention of other researchers who might have missed inclusion on our list.

The questionnaire contained three sections. Respondents were asked, first, to describe their research, to indicate when it would be completed, and to report its anticipated final form (book, article, report etc.) Second, respondents were asked to indicate whether they were receiving funding or sponsorship, and from what sources. A third section of the questionnaire asked for information about teaching activity in the field.

By September, 1979, we had received 144 responses (44.5%), of

which 133 (41.1%) contained information relevant to this study.

These data were supplemented by additional sources, such as project outlines and, in some cases, interviews.

Many respondents were kind enough to include research outlines which aided immeasurably in the preparation of this report. Others provided less detail, especially in specifying the role that federalism played in their research. Response from private research institutions was particularly disappointing, and in general these are omitted from this study. We assume a very large proportion of current research is going on within federal and provincial government agencies - but knowledge of much of it was unavailable.

Undoubtedly some researchers were missed, most likely younger people without an extensive publication record. We apologise to those omitted and urge them to communciate with the Institute in order that our inventory of research may increase. We also take this opportunity to thank those who participated and apologise in advance for any errors of fact or interpretation. These errors will be corrected in subsequent reports. We realize that the present publication embodies all the faults endemic to a new venture.

Part II of this report summarizes our findings by region, discipline, university and subject.

Part III is devoted to brief descriptions of five major group studies currently underway.

Finally, Part IV comprises an annotated directory of researchers on Canadian federalism and intergovernmental relations.

II - SUMMARY

A. Region

Figure I





Figure I indicates that most researchers on Canadian federalism and intergovernmental relations reside in Ontario. To a large degree this reflects the location of the Canadian academic community. Most funding sources for academic research are also located in Ontario.

The most striking feature of Figure I, however, is the surprisingly small amount of research on federalism being undertaken in Quebec. This may suggest that Quebec academics interpreted our questionnaire as referring to the federal system as it now exists, and that studies of present arrangements are regarded as outdated. It may also be that the government of Quebec, by conducting much of its own research, has forced Quebec scholars to seek topics elsewhere. Almost all of our Quebec respondents were engaged in the Osgoode Hall - University of Montreal Constitutional Change Project detailed in Part III of this report.

B. Discipline

Over two-thirds of the research on federalism included in this study has been undertaken by political scientists and economists. (67.3%). The dominance of these disciplines may reflect current interest in the political economy of Canadian federalism, including such topics as federal fiscal arrangements, natural resource questions and related matters.

It is significant that only 6.5% of researchers could be identified as sociologists. Most of the research on the sociological nature of Canadian federalism is being conducted by political scientists.

Although Figure 2 shows a surprising lack of students of public administration (6.3%) a number of political scientists and economists indicated that public administration was a central concern of their work. Almost all the legal academics who responded to our questionnaire were engaged in research on constitutional law and constitutional reform.

C. University

The leadership of Queen's University noted in Table I is partly a result of the ease with which questionnaire recipients were able to return their responses to the Institute. Queen's, however, is also the site both of the Queen's Studies in the Future of the Canadian Communities (see Part III) and this Institute.

Osgoode Hall Law School (at York University) is one of the two sites at which the Osgoode Hall - University of Montreal Constitutional Change Project is located. Taken together these three groups form a very large portion of current research on federalism.

Table I also tends to mitigate the lack of Quebec research noted in connection with Figure I. Three Quebec universities are located in the 'top ten' and this survey has undoubtedly omitted researchers at the University of Montreal, who may be associated with the Osgoode-Montreal Project.

D. Subject

Many of our returned questionnaires provided insufficient detail to categorically determine the subject matter or central theoretical focus of the work in progress. Nonetheless, we thought it useful to include a summary of the general themes which emerged from our data.

To achieve this, each item in the directory was classified by subject according to information available on the questionnaire. Many items were assigned to more than one category as in cases of overlap, or when the central focus was unclear.

Some categories are more specific than others: for example "public finance" might be considered a sub-category of "public policy". We attempted to be as specific as possible in assigning items to categories. These have been grouped in the analysis which follows.




Figure III demonstrates the emphasis currently placed on questions of policy analysis, economics and problems of constitutional law. Sociological and cultural investigations, particularly insofar as Quebec is concerned, appear to have been to some extent neglected as a result.

There is a clear tendency to study <u>provinces</u> rather than regions, again at the expense of sociological undertakings. This may reflect the increased role of provincial governments as actors in contemporary federal-provincial relations.

Finally, our data suggest a remarkable lack of studies being conducted from a comparative perspective.

III - SPECIAL PROJECTS

This section describes five major group studies now in progress. Dates refer to estimated completion.

1) Queen's University Studies in the Future of the Canadian Communities.

This is a series of interdisciplinary studies, sponsored by the Donner Canadian Foundation, to help Canadians understand present issues in federalism and future constitutional alternatives.

II. Osgoode Hall-University of Montreal - Constitutional Change Project

This study consists of an analysis of four proposals for constitutional change: special status, decentralization, sovereignty-association and secession. It has been jointly undertaken by Osgoode Hall Law School and the law faculty of the University of Montreal, and is sponsored by the Donner Canadian Foundation.

Co-chairman of the project are Dean Stanley Beck (Osgoode Hall) and André Tremblay (Law, Montreal).

The project will be completed in June, 1980.

Eight working groups have been established, and are engaged, under the chairmen indicated, in studying the following topics:

- 8. Mechanisms for drawing up a new constitution Edmond Orban (Political Science, Montreal).

III - Atlantic Regionalism Project

This project is an extension of studies undertaken by George Perlin and George Rawlyk for the Task Force on Canadian Unity. Data have been gathered from over 2000 interviews with residents of the Atlantic region, Atlantic deputy ministers, community leaders, Members of Parliament and senior federal government officials concerned with the Atlantic provinces.

The study, directed by George Perlin (Political Studies, Queen's), will consist of about 30 monographs based on these data.

The project is supported by the Institute for Research on Public Policy and is targeted for completion in 1982. The first call for papers has been issued and topics include:

- a) regionalism
- b) economic culture and economic policy
- c) federal-provincial relations
- d) interprovincial cooperation
- e) French-English relations in New Brunswick
- f) Atlantic political culture and effectiveness of political institutions.

IV Economic Council of Canada

1. The Newfoundland Reference in 1978.

In consultation with the Government of Newfoundland and the federal Department of Regional Economic Expansion the Council is engaged in studying Newfoundland's economic development problems. The project, directed by Lawrence Copithorne (Economics, Ottawa), includes 40 researchers, assistants, contractors and support staff based both in Ottawa and St. John's. The Council's final report is scheduled for publication in September, 1980.
