5. Registration in the Engineering & Applied Science Extended (900 section) program incurs a fee of \$448.00 per course. Registration in the Engineering & Applied Science Extended (900 section) program rewrites (Summer Term 2013) incurs a fee of \$466.00 per rewrite. Supplemental examination incurs a fee of \$250.00 per exam (see Faculty calendar for details).
6. Registration in each of MUSC P04, 120, 121, 220, 221, 320, 321, 420 or 421 incurs an additional fee of \$500.00 per course. Registration in each of MUSC 124, 224, 324 or 424 incurs an additional fee of \$1600.00 per course.
7. Registration in PACT 338 or 438 incurs an additional fee of \$400.00 per course.
