1. Tuition for all programs (except Law and Medicine) is assessed on a per unit basis. If you enroll in more or fewer units than the normal load, your tuition will be adjusted accordingly. Engineering & Applied Science students, please see note 2.
2. Engineering and Applied Science Students are assessed on a per unit basis up to 15 units per term. The maximum per term tuition is equal to 1/2 of the tuition fee.
3. The Student Assistance Levy (SAL) is applied on a per term basis using the following charts. There is no ceiling on SAL.

Students in the following programs pay additional fees:

* Computing: Add \$15.00

* Physical & Health Education & Kinesiology: Faculty Society Fee is \$27.00

* Concurrent Education Students not in final year pay the SAF associated with their primary program. They will be charged an additional \$25.00 Concurrent Education Society Fee.

5. Registration in the Engineering & Applied Science Extended (900 section) program incurs a fee of \$448.00 per course. Registration in the Engineering & Applied Science Extended (900 section) program rewrites (Summer Term 2013) incurs a fee of \$466.00 per rewrite. Supplemental examination incurs a fee of \$250.00 per exam (see Faculty calendar for details).

6. Registration in each of MUSC P04, 120, 121, 220, 221, 320, 321, 420 or 421 incurs an additional fee of \$450.00 per course. Registration in each of MUSC 124, 224, 324 or 424 incurs an additional fee of \$1600.00 per course.

7. Registration in PACT 338 or 438 incurs an additional fee of \$400.00 per course.
