Senate Meeting Dates 2011-2012 Report to Senate – February 17, 2011

Background

On January 20, 2011, on recommendation from the Senate Operations Review Committee, Senate approved an amendment to the Rules of Procedure of the Senate, section "I. 1. Meetings, that meetings of Senate shall normally occur on the fourth Tuesday of each month at 3:30 p.m. This change shall take effect September 2011."

Senators also requested as much advance notice as possible of the meeting dates for 2011-2012. However, this request is at odds with the last sentence of the provision. To remove any impediment to an early announcement this year, and in the future, at the request of the Senate Agenda Committee, on February 1, 2011, SORC considered and accepted the following amendment to the Rules of Procedure.
