

Senate Committee on Academic Development Report to Senate - Meeting of February 17, 2011

Enrolment Plan 2011 – 2012

Introduction

At its meeting on January 26, 2011, the Senate Committee on Academic Development considered the Enrolment Plan 2011 – 2012 which was prepared by J. Brady, the University Registrar, following consultation with the Enrolment Planning Task Force. A copy of the Plan is attached to this report.

Analysis and Discussion

The following highlights are noted:

- enrolment planning is a complicated exercise influenced by a number of factors including student demand, institutional capacity and government policy and direction:
- the forecast of the undergraduate and graduate enrolment levels is one factor that influences budget and planning decisions within the institution;
- the Enrolment Planning Task Force, chaired by the Provost, Dr. Bob Silverman, is tasked with exploring options for both short-term and long-term enrolment strategies. Its mandate includes making recommendations on how Queen's will meet its anticipated share of the overall provincial enrolment growth. The Task Force is actively considering both on-campus and off-campus enrolment opportunities and plans to release its final report by June 2011;
- the attached document presents a <u>short-term</u> enrolment recommendation for the 2011-2012 academic year;
- the report recommends an increase in first-entry undergraduate enrolment of no more than 100 students in 2011. It also proposes that previously approved graduate growth targets continue in programs that have not yet reached their enrolment aspirations and where faculty capacity exists.

Enrolment Plan 2011-2012

I. Background

In September 2010, the Principal commissioned a Task Force, chaired by the Provost, to work with the Faculties and Schools to review enrolment options and opportunities and to develop an overall long-term plan for enrolment growth at Queen's. The Task Force has met through the Fall term discussing both short-term and longer-term enrolment plans, considering many options for future potential growth. The Task Force plans to produce a preliminary report in the Winter term. The purpose of this SCAD report is to recommend a short-term enrolment plan for 2011-2012, based on the Task Force recommendations.

II. Full-Time Enrolment

The annual enrolment report focuses on full-time headcount enrolled on November 1 each year. The Senate recently approved a change in the definition of full-time enrolment in programs where registration status (full-time and part-time) is based on course registrations, predominately undergraduate studies. Effective May 1, 2011, the definition of a full-time student will include all students registered in 60% of a full normal course load, revised from 80%. A revised report of November 1, 2010, enrolment results in an increase of 725 reported full-time students, the majority of whom (604) are registered in undergraduate programs in the Faculty of Arts and Science. The definition change results in a total University full-time enrolment of 19,256. It is important to recognize that the 2011-2012 enrolment plan may appear that Queen's is increasing enrolment beyond planned projections, but this reported full-time increase does not manifest in more students physically enrolled on campus. The change in registration status definition will have no impact on the reported enrolment of the incoming first-year class.

III. Specific Short-Term Enrolment Plans 2011-2012

Enrolment planning is influenced by many factors including student demand, institutional capacity (capital and human) and government policy and direction. The Ontario Ministry of Colleges and Universities (MTCU) expects demand for post-secondary education to grow steadily over the next decade at a rate of approximately 2% per year. Preliminary undergraduate application data for September 2011 admission indicates a growth of approximately 2.4% (Ontario high school applicants) over 2010 at Queen's and across the system as a whole.

i.) <u>Undergraduate – First and Second Entry Professional Programs Enrolment Plans</u>

In recognition of current infrastructure limitations (including classroom space, residence capacity and community housing) as well as student support services (including Health, Counseling and Disability Services, Career Services, and QUIC [Queen's University International Centre]), the Task Force recommends an increase in first-entry undergraduate enrolment of no more than 100 students in 2011. The planned increase meets residence capacity and while it can be accommodated and continue to meet the University's guarantee of residence for first-year students, it will reduce the number of upper year students that may be accommodated in residence to those on residence staff (e.g., Dons). While teaching space is also severely constrained, the planned increase can be accommodated within existing resources. The increase in intake will comprise:

Commerce: The School of Business is able to increase intake in September 2011 by 75 students, bringing forward one year an increase previously planned for 2012; significant consultation and planning has occurred to ensure the increased numbers can be accommodated in a core course delivered by Arts and Science and within available classroom space.

Arts and Science: an increase up to 25 students in the BScH Kinesiology program, pending resource allocation opportunities, or in the BScH program. Further, in collaboration with the Faculty of Education, the plan is to increase intake in the Concurrent BAH/BEd program by 20 students, with a concomitant decrease in the first-year BAH class, thereby not impacting overall enrolment;

Nursing: MTCU has confirmed that Queen's may continue to deliver a stand-alone Nursing Program (that is, without a collaborative college partner) with a maximum intake of 92 per year, eligible for funding. The intake target for September 2011 will formally increase to 90 students in response to the increase demand for the program. Student demand for the second-entry "advanced standing track" in which students with post-secondary experience can complete the BNSc program in two years, has steadily grown and Queen's allocated intake will remain at 32 in 2011, and increase to 40 in 2012.

Education: The Ministry will be mandating Faculties of Education across the Province to decrease enrolment over a two year period commencing September 2011. Although formal notification has not yet been received from MTCU, Queen's expected share of the mandated reduction is 75 students from the total 2009-2010 enrolment. The expected reduction of -10% from the uncharacteristic high enrolment in 2009-2010 will enable the Faculty to maintain the 700 target of the past few years and reduce to 675 in September 2012. The Faculty's strategy is to change the mix of students in the final year to increase concurrent relative to consecutive (new entry) students, as illustrated in the Arts and Science plan.

Medicine: The School of Medicine does not plan to proceed with an increase in domestic students as previously forecast, and is planning to enroll up to 9 international students in 2012.

No other undergraduate enrolment changes are planned for 2011-2012

ii.) Graduate Enrolment Plans

School of Graduate Studies: continuing to be influenced by the Ontario Government's Reaching Higher program, enrolment in Masters programs is expected to increase by approximately 5% or 80 students, with modest growth in 2012 to fully achieve current targets; enrolment in PhD programs is expected to increase by 18 students, or 1.5% in 2011, with continuing growth in 2012 to achieve established enrolment targets. The recent policy change from Citizenship and Immigration Canada (CIC) precludes students, including doctoral students, from becoming landed immigrants until they complete their degrees. This policy change may have a negative impact on domestic PhD enrolment, which has historically relied on students converting to domestic enrolment eligible for government funding. CIC has indicated a willingness to revisit the policy with respect to students enrolled in graduate studies and it remains unclear if the policy may be revised for 2011.

School of Business: modest growth in the Masters of Management program is planned for 2011 in the Fall term, with significant growth continuing in the Summer term Graduate Diploma in Accounting program, planned to level off to 120 students in 2011-2012. Enrolment in MBA programs is expected to remain relatively stable at almost 600 students.

IV. International Enrolment

The Principal's vision for Queen's includes the goal of increasing enrolment of international (visa) undergraduate students. The objective for 2011 is to register 150 new first year international visa students, 3.7%, of the undergraduate entering class, with a stretch goal of 4.3% or 175 students in 2011, growing in 2012. The undergraduate admission international recruitment plan has identified four primary foci for admission: international students in Canada, from the North-East U.S., China and Hong Kong and India. International enrolment in graduate programs is expected to maintain at approximately 17% of total full-time graduate enrolment.

V. Conclusion

The first-year undergraduate class, the Class of 2015, will be approximately 3,900 students in September 2011. Total full-time student headcount is projected to be approximately 19,670 students on November 1, 2011, an increase of 2,340 students, or almost 16%, over 2007 (approximately +1,825 undergraduates and 515 students in graduate programs).

The Enrolment Planning Task Force continues to discuss options to meet the anticipated growth share targeted for Queen's (approximately 2,400 undergraduates over five years) and is actively considering both on-campus and off-campus enrolment opportunities. The Task Force plans to release a final report by June 30, 2011.






