

Queen's University Alumni Association  
Final 2020-21 Financial Report  
May 1, 2020 to April 30, 2021

This report summarizes the annual activity in the following three endowed (interest bearing) funds: **The Iris Marsh Alumni Expansion Fund; The F. MacRae Speaker's Fund; and The Alumni Excellence in Teaching Award Fund.** The yearly activity in the QUAA Projects Fund account is also documented.

Following are the fiscal year 2020-21 activity and closing balances in each of these funds. The "Capital Portion" of endowed funds represents the balance upon which interest income is earned, and cannot be disbursed. The "Expendable Portion" represents the amount available to be spent according to the terms of the fund in question.

**1. The Iris Marsh Alumni Expansion Endowment Fund - 60092**
