Professional Summary

I have over 20 years of experience in research, teaching, and advising on environment and development. In this broad field, I have critically explored gender, social equity, and justice issues in upland agriculture, water infrastructure, and governance in riparian contexts, as well as rural-urban livelihoods, disasters, and climate change adaptation in Vietnam, Cambodia, Thailand, and the Philippines. Using a feminist political ecology lens, my work aims to uncover how power shapes daily lives and development policies, and how interventions can become more responsive to real-world contexts and experiences. My current research interests focus on how everyday practices of socio-ecological reproduction support rural communities and have the potential to prefigure alternative futures. I am also intrigued by how persistent colonial and patriarchal logics and rationalities continue to influence water infrastructure and "green" climate solutions in many parts of Southeast Asia.

Formerly, I served as Senior Research Fellow at the Stockholm Environment Institute (SEI) and led the Gender, Environment, and Development (GED) Research Cluster of SEI-Asia in Bangkok, as well as the Gender Equality & Social Equity (GESE) research initiative across all SEI Centres. In these roles, I led research projects that highlighted crucial yet often underestimated links between social justice and sustainability. Based in Thailand but working from a Southeast Asian regional perspective, I collaborated with civil society organisations and international development partners to integrate gender and power into their knowledge agendas through joint policy research projects.

Additionally, I was previously an Associate Professor at the School of Environment, Resources & Development at the Asian Institute of Technology (AIT), an international postgraduate institution in Thailand. I earned my M.A. and Ph.D. in Development Studies from the International Institute of Social Studies (ISS) at Erasmus University in the Netherlands.
