



**General Pediatrician  
Queen's University**

The Department of Pediatrics in the Faculty of Health Sciences at Queen's University invites applications for a General Pediatrician to join its Division of seven. Preference will be given to applicants who are Royal College or American Board certified in Pediatrics and must be eligible for licensure with the College of Physicians and Surgeons of Ontario.

The successful applicant will have a strong interest and associated skills in inpatient and outpatient consultation of acute, emergency and urgent problems of children and adolescents. It is expected that the position will be focused on outpatient consultation or on acute inpatient, emergency and urgent care. Applicants must also demonstrate a strong aptitude for teaching at both the undergraduate and postgraduate levels and/or research. Preference will be given to applicants with extra training in Hospital Care, Pediatric Emergency Medicine or Critical Care. Advanced training or demonstrated leadership in medical education would be an asset. Applicants should provide evidence of an ability to work in an interdisciplinary, collaborative environment.

Nestled on the shores of Lake Ontario, Kingston is a beautiful historic city offering a wealth of recreational activities. Queen's University is one of Canada's premier universities and medical schools. The successful candidate will enjoy exceptional academic, professional, and lifestyle opportunities.

The University invites applications from all qualified individuals. Queen's is strongly committed to employment equity, diversity, and inclusion in the workplace and encourages applications from Black, racialized/visible minority and Indigenous/Aboriginal people, women, persons with disabilities, and 2SLLGBTQ+ persons. All qualified candidates are encouraged to apply; however, in accordance with Canadian immigration requirements, Canadian citizens and permanent residents of Canada will be given priority.

To comply with Federal laws, the University is obliged to gather statistical information about how many applicants for each job vacancy are Canadian citizens/permanent residents of Canada. Applicants need not identify their country of origin; however, all applications must include one of the following statements: "I am a Canadian citizen/permanent resident of Canada"; OR, "I am not a Canadian citizen/permanent resident of Canada". Applications that do not include this information will be deemed incomplete.

The University will provide support in its recruitment processes to applicants with disabilities, including accommodation that takes into account an applicant's accessibility needs. If you require accommodation during the interview process, please contact the Department of Pediatrics through the contact information listed below.

Review of applications will commence immediately and continue until the position is filled. Letters of application (including one of the two statements regarding Canadian Citizenship/permanent resident status specified above) accompanied by a curriculum vitae, an educational dossier and the names and contact information (including email contact) for three referees should be directed to:
