



**Pediatric Cardiologist**  
**Queen's University, Department of Pediatrics**

The Department of Pediatrics in the Faculty of Health Sciences at Queen's University invites applications for a full-time pediatric cardiologist. Preference will be given to applicants who are Royal College or American Board certified in pediatric cardiology and be eligible for licensure with the College of Physicians and Surgeons of Ontario.

This position involves strong collaboration with the Cardiac Diagnostic Team, the Division of Adult Cardiology, and the other pediatric cardiologist at this centre. The successful applicant will be skilled in the performance, interpretation and education of non-invasive cardiac testing and demonstrate a strong aptitude for teaching at both the undergraduate and postgraduate levels. Preference will be given to applicants with special expertise in fetal echocardiography and/or Adult Congenital Heart Disease. Applicants should also provide evidence of an ability to work in an interdisciplinary, collaborative environment.

Nestled on the shores of Lake Ontario, Kingston is a beautiful historic city offering a wealth of recreational activities. Queen's University is one of Canada's premier universities and medical schools. The successful candidate will enjoy exceptional academic, professional, and lifestyle opportunities.

The University invites applications from all qualified individuals. Queen's is strongly committed to employment equity, diversity, and inclusion in the workplace and encourages applications from Black, racialized/visible minority and Indigenous/Aboriginal people, women, persons with disabilities, and 2SLGBTQ+ persons. All qualified candidates are encouraged to apply; however, in accordance with Canadian immigration requirements, Canadian citizens and permanent residents of Canada will be given priority.

To comply with Federal laws, the University is obliged to gather statistical information about how many applicants for each job vacancy are Canadian citizens/permanent residents of Canada. Applicants need not identify their country of origin; however, all applications must include one of the following statements: "I am a Canadian citizen/permanent resident of Canada"; OR, "I am not a Canadian citizen/permanent resident of Canada". Applications that do not include this information will be deemed incomplete.

The University will provide support in its recruitment processes to applicants with disabilities, including accommodation that takes into account an applicant's accessibility needs. Review of applications will commence immediately and continue until the position is filled.
