



**Pediatric Gastroenterologist**  
**Queen's University, Department of Pediatrics**

The Department of Pediatrics in the Faculty of Health Sciences at Queen's University invites applications for a pediatric gastroenterologist. Preference will be given to applicants who are Royal College or American Board certified in pediatric gastroenterology and be eligible for licensure with the College of Physicians and Surgeons of Ontario.

While being a full-time member of the Department of Pediatrics, this position involves strong collaboration with the Endoscopy Program as well as the Divisions of Pediatric General Surgery and Adult Gastroenterology. There are also research opportunities available within the Gastrointestinal Diseases Research Unit (GIDRU). The successful applicant must demonstrate a strong aptitude for teaching at both the undergraduate and postgraduate levels. Preference will be given to applicants with a strong emerging research focus or evidence of high quality research demonstrating the potential for independent research. Applicants should also provide evidence of an ability to work in an interdisciplinary, collaborative environment.

Nestled on the shores of Lake Ontario, Kingston is a beautiful historic city offering a wealth of recreational activities. Queen's University is one of Canada's premier universities and medical schools. The successful candidate will enjoy exceptional academic, professional, and lifestyle opportunities.

The University invites applications from all qualified individuals. Queen's is committed to employment equity and diversity in the workplace and welcomes applications from women, visible minorities, Aboriginal peoples, persons with disabilities, and LGBTQ persons. All qualified candidates are encouraged to apply; however, in accordance with Canadian immigration requirements, Canadian citizens and permanent residents of Canada will be given priority.

To comply with Federal laws, the University is obliged to gather statistical information about how many applicants for each job vacancy are Canadian citizens/permanent residents of Canada. Applicants need not identify their country of origin; however, all applications must include one of the following statements: "I am a Canadian citizen/permanent resident of Canada"; OR, "I am not a Canadian citizen/permanent resident of Canada". Applications that do not include this information will be deemed incomplete.

The University will provide support in its recruitment processes to applicants with disabilities, including accommodation that takes into account an applicant's accessibility needs.
