


Financial Services Releases a New FAST Report: Actuals by Fund

We are pleased to announce that the Actuals by Fund report is now available in FAST. The report is located on the Non Research Reports tab on the Financial Reporting page:



The Actuals by Fund report provides year-to-date Actual Ledger data grouped by fund type (Operating, Non-Credit, Ancillary and Trust & Endowment). Note that this report **DOES NOT INCLUDE COMMITMENTS.**

What should I enter in the report filters?



The report will generate year-to-date results (by selecting the fiscal period filter) for the DEPT, Level and Report Type selected. The report can be run at **3 levels (High, Intermediate and Detail)** and by **2 Report Types (ICR and Non-ICR)**. The **Report Types** are identical at the High and Intermediate levels, but at the Detail level the **Non-ICR** report type mimics the node structure of the **Statement of Operations Non-Research** and the **ICR** report type mimics the node structure of the **Statement of Operations Non-Research ICR** report.

The report has been designed to apply department security. Like most FAST reports department nodes, ranges, wildcards or individual department IDs are available to use in the DEPT filter. Examples: 42001, 42001:42999, 42% or FNS.
