The Department of Geography and Planning, Faculty of Arts and Science at Queen's University invites applications for a Queen's National Scholar position at the rank of Assistant or Associate Professor in urban economic geographies. This is a tenured or tenure-track position with specialization in evolving economic, social, and cultural urban landscapes. We seek an innovative thinker whose research analyzes and addresses urban issues, and whose track record shows evidence of relevant experience working with marginalized communities and conducting community-engaged research. Membership in the Canadian Institute of Planners (or eligibility for membership) will be considered an asset. This position has a preferred starting date of July 1, 2018.

The Department of Geography and Planning at Queen's University has 24 faculty members working in diverse areas of both human and physical geography and planning. The Department hosts undergraduate and graduate programs in Geography, and houses the School of Urban and Regional Planning, which offers a professional Master's program in Planning. The successful candidate will be expected to teach in all of the Department's programs, including the professional Planning program.

The Department seeks to augment its expertise in urban studies, and thus is particularly interested in individuals undertaking research on topics such as the relationship between urban economic development and the changing social, cultural, racial, or gender landscapes within cities. Preference will be given to candidates who have demonstrated scientific engagement within communities in Canada and/or internationally.

The successful candidate will be expected to initiate a high quality, independent research program that is competitive for funding through Canada's Tri-council Awards. The Department of Geography and Planning hosts a series of well-equipped laboratories in Kingston, and has established long-term research relationships with universities around the world, which will give the successful candidate opportunities to fast track their research ideas and to build collaborations with colleagues within the Department and externally.

Candidates must have a PhD or equivalent degree completed at the start date of the appointment. The main criteria for selection are academic and teaching excellence. The successful candidate will provide evidence of high quality scholarly output that demonstrates potential for independent research leading to peer assessed publications and the securing of external research funding, as well as strong potential for outstanding teaching contributions at both the undergraduate and graduate levels, and an ongoing commitment to academic and pedagogical excellence in support of the department's programs. Post Ph.D. experience

involving undergraduate and graduate supervision and teaching is considered a strong asset. Candidates must provide evidence of an ability to work collaboratively in an interdisciplinary and student-centred environment. The successful candidate will be required to make substantive contributions through service to the department, the Faculty, the University, and/or the broader community. Salary will be commensurate with qualifications and experience.

The University invites applications from all qualified individuals. Queen's is committed to employment equity and diversity in the workplace and welcomes applications from women, visible minorities, Aboriginal peoples, persons with disabilities, and LGBTQ persons. All qualified candidates are encouraged to apply; however, in accordance with Canadian immigration requirements, Canadian citizens and permanent residents of Canada will be given priority.

To comply with federal laws, the University is obliged to gather statistical information as to how many applicants for each job vacancy are Canadian citizens / permanent residents of Canada. Applicants need not identify their country of origin or citizenship; however, all applications must include one of the following statements: "I am a Canadian citizen / permanent resident of Canada"; OR, "I am not a Canadian citizen / permanent resident of Canada". Applications that do not include this information will be deemed incomplete.

A complete application consists of:

- a cover letter (including one of the two statements regarding Canadian citizenship / permanent resident status specified in the previous paragraph);
- a current Curriculum Vitae (including a list of publications);
- three samples of research publications;
- a statement of research interests and experience (including graduate supervision);
- a statement of teaching interests and experience (including teaching outlines and evaluations if available); and,
- names and contact information for three referees

The deadline for applications is January 15, 2018. Applications received after the deadline will be reviewed only if the position remains unfilled.
