

**Peacock Post-Doctoral Fellowship  
Department of Political Studies  
Queen's University at Kingston, Ontario**

The Department of Political Studies at Queen's University invites applications for the Peacock Post-Doctoral Fellowship in the area of International Relations. This fellowship offers an exceptional opportunity for a postdoctoral scholar to join our dynamic academic community and pursue research, writing, and teaching.

The fellowship provides a base salary of \$60,000 per year. In addition, the Peacock Postdoctoral Fellow will also be recommended to teach two half-credit undergraduate courses in international relations at approximately \$9,334 per course. The courses will be identified in consultation with the Head of the Department of Political Studies.

The fellowship is for a 12-month term, from July 1, 2026, to June 30, 2027, with the possibility of renewal for a second year.

Applicants must hold a doctorate in Political Science, Political Studies, or a closely related field from a recognized university by the start date or have completed their doctorate on or after August 31, 2022.

The successful applicant will be expected to maintain an active research program, and a postdoctoral supervisor will be named depending on the research specialization of the successful candidate. In addition, the successful applicant will offer public lectures, participate in campus symposiums, and be available for consultation with students and faculty members, as well as class visits.

The University invites applications from all qualified individuals. Queen's is committed to employment equity and diversity in the workplace and welcomes applications from women, visible minorities, Aboriginal Peoples, persons with disabilities, and persons of any sexual orientation or gender identity.

In accordance with Canadian Immigration requirements, priority will be given to Canadian citizens and permanent residents.

To comply with federal laws, the University is obliged to gather statistical information as to how many applicants for each job vacancy are Canadian citizens / Permanent Residents of Canada. Applicants need not identify their country of origin or citizenship; however, all applications must include one of the following statements:

"I am a Canadian citizen / Permanent Resident of Canada"; OR,  
"I am not a Canadian citizen / Permanent Resident of Canada".

Applications that do not include this information will be deemed incomplete.

A complete application consists of:

- 1) a cover letter including one of the two statements regarding Canadian citizenship/Permanent Resident status specified in the previous paragraph;
- 2) a current curriculum-vitae;
- 3) a one-page, single space, statement outlining the applicant's program of post-doctoral research;
- 4) a teaching dossier including potential courses the candidate could teach;
- 5) a writing sample;
- 6) the names of three referees, who will send letters-of-reference separately on or before the deadline of January 31, 2026

Applicants should supply information concerning any interruptions in their academic careers and other factors that may have affected their capacity to complete scholarly work.
