RESEARCH INTERESTS

My graduate training was as a social psychologist working in the areas of aggression and attribution. Early on in my career I became interested in applying psychological research. In particular, I have an established research program in the psychology-law area investigating factors that influence the accuracy of eyewitness identifications and reports as well as the belief of eyewitness testimony. In recent years my studies have taken on a strong developmental flavour with work on identification procedures for use with children and explorations of courtroom procedures used with child witnesses. I continue to explore and develop procedures used by both police and the courts to obtain and evaluate eyewitness evidence.

Beginning in 2002, I provided training on eyewitness identification issues to Canadian judges through a program developed by the National Judicial Institute. These sessions are listed under workshops. By the end of 2004, I reached about 65% of the criminal court justices in Canada (outside of Quebec) through these programs.

As a member of the Technical Working Group for Eyewitness Evidence (U.S. National Institute of Justice), I participated in the development and writing of the American national guidelines for obtaining and preserving eyewitness evidence (published in 1999 as *Eyewitness Evidence: A Guide for Law Enforcement*). I continued to work as a member of the Technical Working Group for Eyewitness Evidence to develop training materials to accompany the guide (completed 2001, released 2002).

I consulted in one of the United Nations war crimes (genocide) trials for Rwanda. The UN prosecutors asked me to consult with them when the defence called an expert witness to testify. During June and July of 1998 I read e-mailed transcripts of the defence expert's testimony and provided comments and suggested questions for cross-examination. In September, 1998 I was called to testify in Arusha, Tanzania.
