Executive Summary

Funding & Governance of the Network

2016 was a very eventful year for the CRDCN, with renewal of SSHRC and CIHR funding that will underpin operation of the Network, and the Queen's RDC, for the next 5 years. In addition, the Network received 5-year CFI Major Scientific Initiative (MSI) funding aimed at supporting operation of individual RDCs. With this renewed and new influx of funding, however, came requirements for more accountability and improved governance of the Network. To that end, the CRDCN now has a new governance structure with a newly minted Inaugural Board intended to ensure due diligence, to provide wise counsel and oversight for the Network, and to meet the requirements of Tri-agency and CFI oversight committees. In addition to the new governance structure, these requirements include more stringent reporting to the funding agencies – resulting in major changes to the content and structure of this year's Annual Report. As a consequence, direct comparisons with previous reports may prove challenging.

Staffing

Overall, changes in governance structure and reporting had no immediate impact on the Queen's RDC (QRDC) in 2016, and the Centre continued to operate normally with one half-time Analyst (18.75 hours per week) and two as-needed Statistical Assistants working about 4.5 hours per week. Specifically, from January to September 2016, the then interim Statistical Analyst worked 15 hours per week (due to contract limitations for 'interim' positions), with Statistical Assistants making up the difference. Once confirmed in the position, the Analyst was able to work 18.75 hours per week for the balance of the year (October to December).

QRDC Advisory Committee

The QRDC Advisory Committee welcomed two new members in 2016 -- John Fisher (Associate VP Research) and Marta Strasnický (Associate Dean, Graduate Studies). Stepping down from these positions (*respectively*) were Yolande Chan and Sandra den Otter – we certainly appreciate their contributions to the Committee.

QRDC Web Page

As mentioned in last year's Annual Report, ORION (Ontario Research and Innovation Optical Network) stopped providing support for web-hosting services as of 31 August, 2016. We were faced with the prospect of migrating the QRDC website with short notice and no clear alternative in place. Fortunately, Igloo, the former web-hosting provider to ORION, was willing to continue to host QRDC web pages for free – independent of ORION support. This gives us the time to consider other web-hosting options. At this time, the most likely contender is the Library's Drupal content management system.

QRDC Teaching and Outreach

The QRDC Academic Director was on sabbatical for all of 2016, limiting opportunities to promote the QRDC in teaching/seminar/reference situations as would normally be the case.

Fingerprinting & Credit Checks

Effective December 1, 2016, two new security measures came into effect for RDC researchers. First, the RCMP now requires all federal public servants in Canada to be fingerprinted as part of their security clearance. Second, the Treasury Board of Canada now requires all federal public servants to undergo a credit check. RDC researchers, who are considered deemed employees under the Statistics Act, are subject to these measures which apply to all new researchers and those renewing their security clearance.

As indicated in previous reports, this major change in access policy presents significant challenges as we try to encourage and grow use of the QRDC. Consultations with Queen's University Library and the QRDC Advisory Committee prompted development of local policies to help mitigate the impact of these measures on researchers. These were fully developed and implemented in 2017.

No new or renewing researchers were affected by these measures in 2016, given the short time these policies were in place in this reporting year.

A LOOK IN TO THE RELATIONSHIP BETWEEN AVERAGE PROVINCIAL UNIVERSITY ATTRIBUTES AND THE EARNINGS OF YOUNG GRADUATES:
PANEL DATA EVIDENCE FROM THREE CANADIAN CYCLES

This essay examines the relationship between university quality and future bachelor degree graduate earnings. It uses three main quality measures including student-professor ratio, median professor salaries (full, associate, and assistant), and tuition fees. These measures are provincial averages taken over relevant years. For this study the National Graduate Survey data from Statistics Canada was used and merged with other Statistics Canada data on universities. Some of the results found differed slightly from other studies in this area and warrant further study.

Box 5a: Summary of Major Achievements and Challenges in the Past Year

Achievements

- Statistical Analyst position confirmed (from interim status)
- Renewed membership of the QRDC Advisory Committee (2 new members)
- Contributed to major funding applications submitted by CRDCN (SSHRC/CIHR, CFI-MSI)
- Initiated development of local policies to address new security requirements (fingerprinting/credit checks)

Challenges

- Continued to work with QUL to manage Network and local funding to ensure ongoing operation of the QRDC and the broader network.
- Continued to work with Statistics Canada managers to evaluate activity levels in the QRDC and to address staffing needs appropriately.
- To that end, worked to meet needs of researchers and demands on the Statistical Analyst by extending hours on an *ad hoc* basis to meet vetting/access demands.
- Cooperated with CRDCN, QUL, and Queen's Office of the Controller in solving problems (minor) with accounting forms for the CIHR and SSHRC grants.
- There were a myriad of problems/challenges associated with the 2016 Annual Report process, driven in large part by new reporting requirements for the CRDCN. Problems included:
 - o The 2016 Annual Report process was extremely challenging – in large part due to innumerable 'new' Annual Report templates foisted upon us throughout the process, with the last template delivered on June 1st, the day *after* the report was originally due for submission. We are all busy people with full schedules; this year, RDCs were obliged to spend an inordinate amount of time checking, rechecking, and checking again the results we were supposed to report back to the CRDCN. This is unacceptable, and needs to be addressed.
 - o While the CRDCN Researcher Survey went well, there were numerous changes in tables and table content over time that made knowing exactly what to report very difficult. Great efforts of the survey administrator aside, the reporting process was a moving target that left us frustrated and, frankly, less than confident in what we ultimately reported. Given that metrics provided in the Annual Report are tied directly to funding, this is very troublesome.

Box 5b: Summary of Major Challenges and Objectives in the Next Year

Challenges

- Evaluating and communicating QRDC activity levels and related staffing/budgetary implications.
- Balancing current demand for better/faster software/hardware with the potential that the CRDCN (including the QRDC) will be moving to a new thin-client environment (dependent on new funding) that will render investments in better/faster local hardware/software obsolete. In an ironic twist, recent investments in more powerful software (e.g. Matlab add-ons¹) may be driving demand for faster hardware.
- Contribute to new granting applications (e.g. CFI IF Cyberinfrastructure Grant) in support of CRDCN activities.

Objectives

- Implement new security measures and local policies (i.e. QUL paying for third-party fingerprinting) and monitor impacts on QRDC researchers.
- Contribute to CARL (Canadian Association of Research Libraries) lobbying efforts to have security measures changed to better 'fit' the reality of RDC researchers (i.e. change implications of 'deemed employee' status).
- Work with Statistics Canada and Statistical Analyst to monitor and address QRDC hours of operation and associated budgetary implications.
- Monitor and address changes that may arise if the CRDCN receives CFI funding to build a thin-client system for the Network and/or improved metadata for discovery and exploration of data.
- Work with CRDCN to improve communication and streamline workflow associated with reporting and writing RDC Annual Reports.
