**5. Registration in the Engineering & Applied Science Extended (900 section) program incurs a fee of \$539.63 per course. Registration in the Engineering & Applied Science Extended (900 section) program rewrites (Summer Term 2021) incurs a fee of \$300.00 per rewrite. Supplemental examination incurs a fee of \$300.00 per exam (see Faculty calendar for details).**

**6. Registration in PACT 338 or 438 incurs an additional fee of \$400.00 per course.**
