1. Tuition for all programs (except Law and Medicine) is assessed on a per unit basis. If you enroll in more or fewer units than the normal load, your tuition will be adjusted accordingly. Engineering & Applied Science students, please see note 2.
2. Engineering and Applied Science Students are assessed on a per unit basis up to 16.1 units per term. The maximum per term tuition is equal to 1/2 of the tuition fee.
3. The Student Assistance Levy (SAL) is applied on a per term basis using the following charts. There is no ceiling on SAL.

**5. Registration in the Engineering & Applied Science Extended (900 section) program incurs a fee of \$519.37 per course. Registration in the Engineering & Applied Science Extended (900 section) program rewrites (Summer Term 2017) incurs a fee of \$466.00 per rewrite. Supplemental examination incurs a fee of \$250.00 per exam (see Faculty calendar for details).**

**6. Registration in PACT 338 or 438 incurs an additional fee of \$400.00 per course.**
