The School of Religion at Queen's University invites applications from suitably qualified graduate students at Queen's University interested in teaching a course in **Religion and Social Movements (RELS 232) as a Teaching Fellow**. This is an on-campus lecture course with an expected enrolment of ~50 undergraduate students. This is a Fall term appointment for the period September 1 to December 31, 2022 with classes in session from September 6, 2022 to December 5, 2022.

The University invites applications from all qualified individuals. ### Course Description:

#### **RELS 232 Religion and Social Movements Units: 3.00**

This course will examine the field of social movements studies, with a particular focus on how religion has played a role in the rise of social movements, how religious communities have been influenced by social movements, and how mobilization and activism around social justice issues is coloured by religion and culture.
