The School of Religion at Queen's University invites applications from suitably qualified graduate students at Queen's University interested in teaching a course in **Christianity (RELS 218) as a Teaching Fellow**. This is an on-campus lecture course with an expected enrolment of ~50 undergraduate students. This is a Winter term appointment for the period January 1 to April 30, 2023 with classes in session from January 9, 2023 to April 10, 2023.

The University invites applications from all qualified individuals. All qualified candidates are encouraged to apply; however, Canadians and permanent residents will be given priority.
