The School of Religion at Queen's University invites applications from suitably qualified graduate students at Queen's University interested in teaching a course in **Religion and Sex (RELS 236) as a Teaching Fellow**. This is an on-campus lecture course with an expected enrolment of ~95 undergraduate students. This is a Winter term appointment for the period January 1 to April 30, 2024 with classes in session from January 8, 2024 to April 8, 2024.

The University invites applications from all qualified individuals. Queen's is strongly committed to employment equity, diversity and inclusion in the workplace and encourages applications from Black, racialized/visible minority and Indigenous/Aboriginal people, women, persons with disabilities, and 2SLGBTQ+ persons. All qualified candidates are encouraged to apply; however, in accordance with Canadian immigration requirements, Canadian citizens and permanent residents of Canada will be given priority.
