- Meg Muir and outdoor crew responsible for main campus fields and west campus stadium inspections
- 6. New Business:

- Protocol for Active Threat/Shooter on campus
 - DP not attendance to provide update
 - We follow the same protocol as everyone else on campus but issues raised that the university protocol doesn't fully align with our operations.
 - Appel we will not create out own policy, maybe we need a separate procedure
 - Do outdoor alarms go off around campus for this? What are the outdoor alarms used for?
 - TD to review with DP and send any notes
- Pool project
 - Pool is closed, stanchions around pit to prevent falls
 - 1. Do we have signage outside of pool "DANGER OPEN PIT"
 - TD working with James Dick and H&S to combat corrosion
 - 1. Stainless steel around AEDS and fire extinguishers are corroding very quickly, is there some sort of thing we can put on to combat this corrosion

Other

- Should we add something to intranet to submit things for H&S

- Appel we are not meeting all the requirements of H&S, when you have a regular inspection of FAC and Office areas combined, there are things that need to be part of a general inspection form.
