



COPYING AND MICROFILMING YOUR THESIS

As a graduate student registered in a degree program at Queen's University involving research you are advised that as a condition of being awarded the degree you will be required to grant a non-exclusive license to reproduce any thesis submitted as part of your degree program, to the both Queen's University and to Library and Archives Canada. The *Queen's University Copyright Licence* is completed online when you submit the thesis to QSPACE. The Library and Archives Canada *Theses Non-exclusive Licence* form must be signed and returned to the School Graduate Studies as soon as possible. You will not be considered to have met degree requirements unless these actions have been completed.

The non-exclusive copyright licences granted by these forms permit the widest use of the results of your scholarship. Users of any copies must, of course, respect your copyright--they must not plagiarize (pass off your work as their own), further copy your thesis, nor publish extensive extracts from it without your permission. In their own scholarly work, users may quote briefly from your work, giving proper acknowledgement. If you wish to publish your thesis, the publisher will likely require substantial editorial changes. You will then be able to copyright the new publication. In other words, it is not necessary to withhold your original thesis from publication, microfilming by Library and Archives Canada, or use, simply because you expect to publish a revised version.

If you and your supervisor know that other researchers are working on the same or a very closely related topic, you may be concerned that the release of your thesis will jeopardize the value of your work, or risk use of your results prematurely or without adequate acknowledgement. Generally, your best defense against these possibilities is the quick release of your copyrighted thesis, including listing in **Dissertation Abstracts International**, or **Masters Abstracts International**. However, if at the time of submitting the thesis for binding, you would like to protect any rights to immediate commercial publication, or to obtain a patent which may arise from the research, or as a result of any contract made with a third party, you may make an application, in writing, to the Dean of Graduate School requesting that the thesis be withheld (**restricted**) from microfilming or deposit in any library for an initial period of six months (no reason or explanation required).

You must submit any request for extension of the restriction in writing one month prior to the termination of the previous period. You and/or your supervisor may be required to appear before the Dean of the Graduate School to justify the extension of the restriction. The extension will be ruled on by the Dean, who may seek the advice of informed experts such as the Advisory Research Committee, PARTEQ, etc. Subsequent requests for extensions must follow the same procedure. The total period of restriction will not exceed two years from the date of submission of the final copies of your thesis to the Graduate School (*General Regulation under "Thesis" in the School of Graduate Studies Calendar for more information*).

Further information on copyright, publication or microfilming of your thesis can be gained from the Office of the Chief Librarian at Queen's University. Advice on patenting of inventions may be obtained from the Office of Research Services or by consulting your own legal advisor.
