What Will I LEARN?

A professional degree in Public Administration can equip you with valuable and versatile skills, such as:

Strategic Thinking:

- Articulate the political, institutional, legal, and administrative context in which policy is made and implemented.
- Recognize the values and principles of Canadian democracy.

Engagement & Communication:

- Engage and collaborate with diverse stakeholders and partners.
- Demonstrate high quality, professional verbal and written communication skills.
- · Prepare high quality written and oral material.

Analysis & Application:

- Apply relevant theories, principles and techniques of policy analysis to identify and assess public policy issues and devise options to resolve them.
- Identify, synthesize, analyze and integrate relevant and appropriate sources of information.

Method of **COMPLETION**

- Master of Public Administration (1 year): 12 half-credit courses or 10 half-courses plus a research project.
- Combined Juris Doctorate/Master of Public Administration: (3 years): course work and the opportunity to participate in the certificate program in Public International Law at the Bader International Study Centre located at Queen's Herstmonceux castle in England, or an international study exchange to pursue broader opportunities.

What do I need to know to APPLY?

Academic Requirements

- 4 year undergraduate degree.
- **Grade requirements:** minimum upper second class standing (B+ average) in the last 2 years of study. Competitive scholarship applicants must have an A- or 3.7 GPA in the last two years of study.
- **JD/MPA applicants** must have completed a Bachelor's honours degree, with an average or 3.7 GPA in the last two years and an LSAT score above the 80th percentile.

Additional Requirements

- Statement of Interest.
- A GRE/GMAT test examination is required if your previous degree is from outside of North America.
- If English is not a first language, prospective students must meet the English language proficiency requirements in writing, speaking, reading, and listening. The School of Graduate Studies and Postdoctoral Affairs (SGSPA) requires the following minimum scores: TOEFL (paper based): 550, (2) TOEFL iBT: Writing (24/30); Speaking (22/30); Reading (22/30); Listening (20/30), for a total of 88/120 (applicants must have the minimum score in each test as well as the minimum overall score), or (3) IELTS: 7.0 (academic module overall band score), or (4) PTE Academics: 65.

Key Dates & Deadlines

Application deadlines:

- MPA Program: February 1.
- MPA/JD Program: January 15 (through SGPSPA for MPA), November 1 (through OLSAS for Law). Notification of acceptance: no later than May 15.

What about **FUNDING?**

MPA students are not guaranteed funding, but there are internal Queen's graduate awards available that vary from \$1000 - \$10,000. Applicants are automatically considered for the internal awards and will be notified if successful.

We encourage all students to apply for external funding from Ontario Graduate Studies (OGS), Social Sciences and Humanities Research Council (SSHRC) and other sources. Queen's will automatically issue a \$5,000 top-up to Masters winners of federal government tri-council awards.

Experiential learning is an important aspect of Queen's MPA programs and we strive to incorporate the practical application of skills a significant component of the learning experience. 
WHERE can an MPA take me?
